The combined provisional seniority list of class IV/lowpaid employees coming under the state subordinate service of this department who are eligible for promotion by transfer to the cadre of Lower Division Typist in the 10% quota earmarked for filling from these employees, was published and circulated among all individuals concerned, inviting claims and objections if any vide order read as per 4th paper above. The provisional seniority list was prepared and published based on the date of

advise by Kerala Public Service Commission in the lower cadre of each individual.

Later the seniority list of Low Paid Employess for promotion by transfer to the cadre of LD Typist was finalised as per Order read as 5th paper above. In the final seniority list published the seniority was taken in the order of date of passing of the required test qualifications prescribed for by transfer appointment. The final seniority list was published in that criteria on an understanding that vacancies are reserved for filling in the 10% quota earmarked for appointment through promotion by transfer. There is wide spread complaints in publishing the seniority list fixing seniority on the basis of date of acquiring test qualification. Verified the matter in detail and found that the criteria adopted for fixing seniority is irregular. Accordingly the final seniority list published is cancelled as per Order read as 6<sup>th</sup> paper above.

As per Rule 27(bb) of KS & SSR, promotion in a service or class which depends upon the passing of any examination shall be made with reference to the conditions existing at the time of occurrence of vacancies. In the references read 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> papers it is categorically stated that the eligibility of the individuals for promotion by transfer to the cadre of L D Typist should be based on the seniority in the 'Entry cadre' and also based on the 'Qualifications'. The qualifications prescribed for promotion by transfer to the post of LD Typist are KGTE Lower(Eng), KGTE Lower(Mala) and Computer word Processing. Considering the above facts it is proposed to modify the provisional seniority published earlier with additional information of the candidates such as the date on which they acquired the eligibility of passing the mandatory tests of KGTE Lower(Eng), KGTE Lower(Mala) and Computer word Processing, the date of declaration of probation of each individual in the entry cadre and including the names those who are eligible for promotion but not included in the provisional seniority list published earlier and excluding the names of those candidate whose names were included in the earlier list though ineligible.

In the Provisional Seniority list published earlier Smt.Sukhitha.K.S, Clerical Attender, O/o the CTO, Nedumangadu was included as Sl.No.4 based on the details in respect of the individual furnished by Deputy Commissioner, Thiruvananthapuram. But on further verification, it is found that the documents produced in support of word processing is a certificate issued from Keltron to the effect that Smt.Sukhitha.K.S has completed one year Computer Programming Assistant. But the above certificate issued by Keltron is not recognised as the qualification to the post of LD Typist by KPSC. So the name of Smt.Sukhitha.K.S is deleted from this provisional seniority list.

In para (4) of the Government order read as 1<sup>st</sup> paper issued on the matter of by transfer appointment, it is specifically stated that those who were completed their probation and also those who completed at least three years duty in the lower cadre are eligible for the by transfer promotion. On further verification of the provisional seniority list published it is found that Smt.Sreekala.R.K(Sl.No.29), Smt.Vijayasree.P.V(Sl.No.30) and Smt.Maya.O.N (Sl.No.31) who were included in the earlier provisional list were not completed the required three years duty in their respective lower cadres. So Smt.Sreekala.R.K(Sl.No.29), Smt.Vijayasree.P.V(Sl.No.30) and Smt.Maya.O.N (Sl.No.31) are removed from this provisional seniority list.

Smt.Sindhu.P.B, Sri.Santhoshkumar.C.S, Smt.Fousjan.S, Smt.Reeba.K, Smt.Lekha.N.V, Smt.Rashmi.T.V and Smt.Ajitha.R.S. who were members in the Low Paid ategory of employees coming under classIV/subordinate services were already promoted by transfer as Lower Division Typists by the concerned Deputy Commissioners. So their name are included in the modified Provisional Seniority list.

The names of the following individuals are also included in the modified Provisional Seniority list as they were also acquired eligibility and passed the prescribed qualification for promotion by transfer to the post of LD typist.

The objections received should be forwarded to the Commissionerate with specific before the their remarks prescribed period. Claims and objections received after the time limit will not be entertained. The Controlling Officers are directed to verify the particulars furnished in the list with reference to the Service Books of the individuals working under their control and bring to the attention of this office any omissions, corrections and mistakes, if noticed.
