**ORDER NO.CT.568/2016-G2 DATED:14/09/2017**

As per G.O read as (1) to (4) above, Government have issued orders to fill 10% of the vacancies existing in the cadres of lower division clerk and lower division typist in Government departments from the last grade employees and the employees of lower cadre in the subordinate services (employees whose scales of pay are lower than those of lower division clerk/typist) on appointment by transfer in such department on the basis of qualification and seniority in the cadre. Such appointments by transfer are subject to the following conditions.

1. The employees who are eligible for promotion by transfer should have completed probation in their lower cadre.
2. Such employees should have put in three years of service.

As per G.O.(MS)No.21/2011/P&ARD dated 01.07.2011 Government have revised the qualifications for the post of Lower Division Typists (Various departments) but, has subsequently frozen the G.O demanding the qualification as 'plus 2' vide G.O (Ms) No. 24/2015/P&ARD dated 27/07/2015. At present, the qualification to the post of Lower Division Typists is as under, as prescribed in G.O.(P)No.17/2005/P&ARD dated 09.05.2005.

- 1.S.S.L.C or its equivalent.
- 2.Lower Grade Certificate in Typewriting Malayalam(KGTE) or its equivalent.
- 3.Lower Grade Certificate in Typewriting English (KGTE) and Computer Word Processing or its equivalent.

*Note:- Those who have passed the KGTE Typewriting before January, 2002, should produce separate Certificate in 'Computer Word Processing or its equivalent.*

The provisional seniority list of last grade employees and the employees of lower cadre in the subordinate services who were eligible for promotion by transfer to the cadre of Lower Division Typist in the 10% quota earmarked for the post as per the Govt. Orders cited, was prepared based on the details furnished by all Deputy/Assistant Commissioners and was published vide Order No.CT/568/2016/G2 dated 09.01.2017 of JC-I. This list was prepared and published based on the date of advise by Kerala Public Service Commission in the lower cadre of each individual. The claims and objections received were examined in detail. Objections raised

were mainly against fixing the seniority of the individuals in the order of the date of advise by Kerala Public Service Commission. As per Rule 28(bb) of KS & SSR, 1958 '*promotion in a service or class which depends upon the passing of any examination (General or Departmental) shall ordinarily be made with reference to the conditions existing at the time of occurrence of vacancies and not with reference to those at the time when the question of promotion is taken up.*' The qualifications prescribed for promotion by transfer to the post of LD Typist are KGTE Lower(Eng), KGTE Lower(Mala) and Computer Word Processing. An individual should be considered for promotion by transfer to a vacancy in the post of LD Typist only if the individual had passed all the three tests on the date of occurrence of that vacancy. Considering the above facts the provisional seniority list was revised by assigning seniority of individuals in the order of the date on which they had acquired the eligibility of passing the mandatory tests of KGTE Lower(Eng), KGTE Lower(Mala) and Computer Word Processing and also on the basis of the seniority in the 'Entry cadre' .The Provisional list was finalised as per order No.CT/568/2016/G2 dated 23.05.2017 of JC-I and circulated among all concerned officers. Many of the concerned officers raised objection against the change of criteria of the seniority list finalized. Hence the matter was once again verified in detail and found that the criteria adopted for fixing seniority was irregular. Accordingly the final seniority list published was cancelled vide order No.CT/568/2016-G2 dated 27.05.2017 of JC-I.

Subsequently, a modified Provisional Seniority List was published and circulated among the individuals concerned, inviting claims and objections, if any, vide order No.CT/568/2016-G2 dated 27.05.2017 of JC-I. The claims and objections received against the modified Provisional Seniority List have been examined with reference to the government orders issued on by transfer appointment to the post of LD typist and also with relevant rule provisions. The report furnished by the controlling officers of those employees who filed objections have also been taken in to consideration in finalizing the list.

The objections received have been examined in detail and is discussed and disposed of on its merit as detailed under.

Smt.Ajitha.R.S, Lower Division Typist, Spl.Circle, Thiruvananthapuram and Sri.Naseerkhan.P, Clerical Attender, O/o the CTO, 2<sup>nd</sup> Circle,

Thiruvanthapuram who were included in the provisional list have filed objection against the inclusion of Smt.Sasikala.D.G, Clerical Attender as Sl.No.5 in the list published vide paper read (8) above stating the reason that she had joined in Ernakulam District earlier and was transferred to Thiruvananthapuram District as per Order No.A6-11500/2001/TX dated 06.03.2001. So she is eligible for a seniority only after the date of joining in the new district. The objections raised were examined in detail and found that Smt Sasikala.D.G had joined as peon in the Commercial Tax department in Ernakulam District as per the advise letter No.E11(3) 2859/96 dated 25-09-2000 of KPSC, District office, Ernakulam. Thereafter, on her request, she got inter-district transferred to Thiruvananthapuram District as per Order.No.A6-11500/2001/TX dated 06.03.2001 of Joint Commissioner-I. She had joined duty in Thiruvananthapuram District on 24-03-2001. Rule 17 (d) of Special Rules for the Kerala Last Grade Service rule stipulates that:-

*(d) Transfers on request. \_ Probationers, approved probationers or full members desiring transfer from the jurisdiction of one appointing authority to that of another appointing authority may be permanently transferred, mutually or otherwise, with the mutual consent of the appointing authorities concerned, if the persons desiring transfer (i) forgo their right to seniority based on rule 14 and each of them takes his rank last in the list of probationers, approved probationers or full members, as the case may be, for the administrative unit to which he is transferred as it stands on the date on which he joins the new Unit and (ii) receive no T.A. For the journeys to the places to which they are transferred.'*

In the light of the above rule position, she is eligible for seniority with effect from the date of joining in Thiruvananthapuram district that is w.e.f 24.03.2001. Hence the seniority of Smt.Sasikala.D.G is reassigned in the final seniority list as Sn.No.8 in between Smt.Fousjan.S(Sn.No.7) and Smt.Reeba.K(Sn.No.9).

Smt.Sukhitha.K.S, Clerical Attender, O/o the CTO, Nedumangad has filed objection against non-inclusion of her name in the modified provisional seniority list stating that the certificate issued by Keltron under NORAD Scheme conducted by software Training Centre is recognised as qualification to the post of LD Typist and is approved by KPSC. The objection filed by Smt.Sukhitha.K.S, Clerical Attender was examined. Since the objection of the individual is with regard to the the admissibility of the certificate issued from an organisation under Kerala Government

undertaking, it was decided to verify the veracity of her claim. So a clarification was sought from Kerala Public Service Commission, Thiruvananthapuram as per this office letter No.CT/568/2016-G2 dated 13.06.2017 marking a photocopy of the certificate produced by the individual. Against the clarification sought, the KPSC, Typm as per Lr.No.DR1(2) 6989/08/GW/D4 dated 03.07.2017 has informed that the certificate issued by Keltron under NORAD Scheme conducted by software Training Centre is not accepted as equivalent to Computer Word Processing for the post of Lower Division Typists. So the objection filed by Smt.Sukhitha.K.S against the non inclusion of her name in the list is rejected and hence she is not eligible to be included in the final seniority list.

Smt.Remani.M.V, Clerical Attender, O/o the IAC, Pala filed representation dated 26.04.2017 stating that she had acquired qualification of KGTE Eng & Mala(L) but have only appeared in the computer word processing examination and the certificate is expected to get in the next month. As per G.O.(P)No.17/2005/P&ARD dated 09.05.2005. one among the three essential qualification for the post of lower division typists prescribed is a Lower Grade Certificate in Typewriting English (KGTE) and Computer Word Processing or its equivalent. The individual has not produced the required certificate of computer word processing till date, but produced only a copy of the admission ticket for Kerala Government Technical Examinations for the examinations held in February 2017 with register No.12653. Hence Smt.Remani.M.V is not included in the final seniority list as she has not satisfied the prescribed qualifications. .

Further, Smt.Remani.M.V, has objected the inclusion of Sri.Sunilkumar.V.G in the list stating that he has not acquired the Typewriting Malayalam Lower certificate, which is expected to get shortly. The contention raised has been examined. As per G.O.(P)No.17/2005/P&ARD dated 09.05.2005. one among the three essential qualification for post of lower division typists prescribed is a Lower Grade Certificate in Typewriting Malayalam (KGTE) or its equivalent. Sri.Sunilkumar.V.G has produced an attested copy of the mark list issued by the Secretary, Board of Public Examinations dated 25/11/2016 for the Kerala Government Technical Examinations held in June 2016 with register No.16062339 wherein he has secured 63% and 70% for paper I and II respectively in Typewriting Malayalam Lower. Therefore, the objection filed by Smt.Remani.M.V, Clerical Attender against the inclusion of the name Sri.Sunilkumar.V.G (Sn.No.15) in the list is rejected.

Smt.Manju.V.K has filed objection against the placement of her name below the name of Smt Christi Bai.K in the modified provisional seniority list. Her contention has been verified with the advise letter No.DTD(3) 3527/96(5) dated 05.08.2004 issued by the District Officer, Kerala Public Service Commission, Thiruvananthapuram. In the advise letter the name of Smt.Manju.V.K is placed above the name of Smt Christi Bai.K. Hence, the seniority of Smt.Manju.V.K is reassigned and she is placed as Sn.No.19 in between Smt.Latha.S(Sn.No.18) and Smt.Christi Bai.K(Sn.No.20).

Smt.Sheeba Ammal.K.R, Office Attendant, O/o the CTO, 2<sup>nd</sup> Circle, Kottayam has filed objection for not including her name in the seniority list . On verification it is found that she had passed KGTE English(H) and KGTE Malayalam(L).The individual has not produced the required certificate of computer word processing till date, but produced only a copy of the admission ticket for Kerala Government Technical Examinations for the examinations held in February 2017 with register No.12661. The individual has not satisfied the qualifications required for the post of lower division typists prescribed as per G.O.(P)No.17/2005/P&ARD dated 09.05.2005.. Hence her name is not included in the list.

Smt.Nisha.P, Office Attendant, O/o the IAC(I), Kozhikode has filed objection for not including her name in the list. Her objection was examined in detail and found that she had joined duty in this department on 12.11.2014. As per G.O(P) No.1/2014/ P&ARD dated 03.01.2014 of P&ARD, appointments by transfer are subject to the following conditions.

1. The employees who are eligible for promotion by transfer should have completed probation in their lower cadre.
2. Such employees should have put in three years of service.

Smt.Nisha.P has joined duty in this department on 12.11.2014 as per advise Lr.No.DII(2)647/10-6 dated 10.10.2014 of KPSC, District Office, Kozhikode. Her probation in the cadre of Office Assistant was declared as per order No.KE2-959/2016 dated 12.11.2015 of DC Kozhikode. But, she has not put in three years of service. Therefore, the objection raised is devoid of any merit and is rejected. Hence her name is not included in the list.

In this seniority list, there are two persons with the same name and initials as 'SANTHOSH KUMAR C.S'. So their names are tagged with

'Sr' and 'Jr' in the order of their seniority for identification.

The final seniority list of the last grade employees and the employees of lower cadre in the subordinate services of this department who are eligible for promotion by transfer to the cadre of Lower Division Typist has been prepared as per the government orders read above with Rule 27(a) of the KS&SSR,1958.

In the circumstances, stated above the modified provisional seniority list of the last grade employees and the employees of lower cadre in the subordinate services of this department who are eligible for promotion by transfer to the cadre of Lower Division Typist is finalized.
